

# **Tuftonboro Parks & Recreation Commission Meeting** **February 6, 2024 Minutes:**

Meeting called to order by Chair Eileen Gil at 5:05 PM.

Attendees: Dennis Zilembo, Parks & Recreation Director, Eileen Gil, Chair, Lloyd Wood, Alternate Member, Bob Murray, Selectmen Representative, Sarah Warner. Absent members: Joyce Lake, Zack Tufts, Mitchell Tufts, Jeff Reisner. With four voting members, a quorum made the meeting official.

Eileen Gil stated that our first order of business was to explain that Parks and Rec has two separate Bank accounts. One is **The Revolving Fund** and the other is **The Trail** fund. To correct the previous motion from the January meeting on this subject,

Eileen made a motion that a fee of \$6250. (approval by the Selectmen) be paid to Andrew Lester, Bella Terra Design LLC for the deposit of our design site plan for Central Park upgrade. These funds will be taken from The TRAILS account. Motion was seconded by Sarah Warner. The vote passed by a 3 to 1 margin. Bob Murray was the only person against the payment. He did go on to state he is in favor of the project, but not a deposit coming from our trail fund.

Bob Murray explained that the Selectmen approved a Town Warrant article for the Central Park project for \$10,000. Discussion with regards to our article on how we should present it to the public. Our Parks Director should present this information to the people. Discussion as whether our Designer, Andrew Lester should be present at this town meeting?

**Director's report:** The good news that 4 of our Tuftonboro youths returned this past week from Las Vegas, Nevada for the Punt, Pass & Kick Nationals! We did come away with a "National Champ" in Brendan MacPhee.

Cornhole league has poor sign ups, so a 3 on 3 mens basketball league will be run by our department in its place.
