The purpose of this hearing will be to review the proposed Carroll County Communications District Agreement which would provide state of the art symmetrical high speed broadband internet connectivity and service to every residence and business within Carroll County.

Chris Ruel presented the attached update. There was a lot of discussion about C&D and Chairman Albee mentioned getting rid of C&D completely. Chris read a memo that he created that read "Beginning Tuesday December 6, 2022, it will be the policy for our attendants to cut the power cords off any electronic device or bulky item delivered to the Transfer station. In an effort to increase the recycling of the Tuftonboro Transfer Station as well as increase the revenue return to the Town. The cut cords will be placed into a designated receptacle on the loading dock and shipped by weight to a recycling facility when it becomes necessary."

Chief Thompson presented the attached update. Chairman Albee asked Chief Thompson to get 3 bids together for replacing car 1 and to coordinate with Jane from the budget committee to get the fire info to her before the budget committee meeting on December 13.

Tom Taylor and Tom Willand from the Wolfeboro snowmobile club talked to selectmen about the possibility of moving the "snack shack" to an area that is more accessible for our members and the snowmobile community. The trail system runs through the back side of 20 Sargent Crossing Road. That area could provide a level spot, more secure and easier access for the club to maintain the staff back where the snowmobile trail goes through. Chairman Albee asked Tom Taylor to put a stake in the ground where the proposed site is, and he will ride over and take a look at where they would like it.

The dry hydrant at Farm Pond Subdivision was damaged during there yearly maintence of weeds from the pond. The department received a call from Ray Torres of Farm Pond who is the president of the association. We met with Mr. Torres on 11/21/2022 and found that the pipe and strainer were broke off below the water. The pond will have to be pumped down in the spring and the pipe will have to be dug up to the point where we find no more breaks in the PVC pipe. The Farm Pond Association will be paying for the repair.

A radio cabinet was set at East Wakefield's new cell tower sight on 11/22/2022 @ 3536 Province Lake Road. This part of the radio upgrades taking place with the OVMAA. The cabinet for the Tuftonboro's sight is on order through Ossipee Mtn Electronics.

The final invoice for Rescue 1 brake repairs and rear end fluid flush was \$2,375.59 When the brakes were replaced it was found the rear end had water in it.

Boat 1 has been taken out of service for the winter it is at Central station on its trailer until the lake starts to freeze over. The fire department along with Melvin Village Marina will be working on the boat over the winter.

The ice eater was placed at Pier 19 where we have a certified water source for ISO to fill fire trucks. Captain Pike placed the unit when it was warmer weather so it could be tested, he then became busy and forget to check it when the temperature became colder. The unit it set up to run for 3 hours a day and is also on a special temperature timer. A subject came to central station and was very upset that the unit was running with no ice. Once Captain Pike was notified of the issue the unit was unplugged until there is ice.
