Selectmen's Meeting Final Minutes 4:30pm – Town Offices

Monday, March 27, 2023

Present: Chairman Albee, Selectman Pike, Selectman Murray, Susan Weeks, Adam Thompson, and Administrative Secretary Cami Wakefield.

CALL TO ORDER

Chairman Albee called the BOS meeting to order at approximately 4:30pm and lead the Pledge of Allegiance. Chairman Albee added that the first order of business is to elect a new Chairman. Selectman Murray asked who wants to be chairman and Chairman Albee added that traditionally it would go to Selectman Pike. Selectman Pike added that he would like to wait until Selectmen's Updates at the end of the meeting to do the vote, simply because it keeps things rolling and the transition would be milder and then at the next meeting, he would be the full Chairman.

REVIEW AND APPOVAL OF MINUTES

Selectman Murray made a motion to approve the 3.6.2023 BOS meeting draft minutes as written, Selectman Pike seconded, motion carried 3-0.

Selectman Pike made a motion to approve the 3.6.2023 BOS Non-Public session per RSA91-A:3, II (I) draft minutes as written, Selectman Murray seconded, motion carried 3-0. Chairman Albee made a motion to have these minutes remain sealed, Selectman Murray seconded, motion carried 3-0.

Selectman Murray made a motion to approve the 3.14.2023 BOS meeting draft minutes as written, Selectman Pike seconded, motion carried 3-0.

APPOINTMENTS

Sue Weeks was in to talk with Selectmen first about town roads. Sue admitted that she has slowed down on her research work on town roads and is trying to declutter and catch up on scanning all the papers. Sue noted that she has a lot of research into town roads. Piper road for example, there was a big discussion about whether it was a town road or not and Sue did research on that to determine that it is a town road. Sue will bring in the paper for Piper Road and put it in the town roads drawer in the file room. Sue informed selectmen that there is a file out there with a folder in it for every road in Tuftonboro and whatever information that we have about that road in the file. Sue added that there is also a chart in that file cabinet that was put together in 2009 that John Simms provided to the town.

Secondly, Sue mentioned to Selectmen that she feels that the AG Commission is something that we should have as an active commission. Chairman Albee noted that the community garden is still going but that the AG commission sort just imploded. Sue recommended keeping the commission going as it is already established it just doesn't have any members on it. Sue thought a 5-member commission would be sufficient. Selectmen Pike added that it has been assured that the garden plots are all paid for and that the garden members can run it by themselves. Selectman Murray made a motion to appoint Susan Weeks to AG Commission, Selectman Pike seconded, motion carried 3-0. Selectman Pike will remain as the Selectmen's representative for the AG Commission.

Chief Thompson presented the attached update. Selectman Pike asked to speak on this before the Chief got started. He noted that it had been reported to him that at the Ossipee Valley Mutual Aid Association meeting the other night at

our fire house that there were multiple people from State organizations there and they were very impressed with our fire department and our fire building so he would like to give the Chief an at a boy for that.

The Administrative Secretary also added that the Fire Department got a thank you letter from the Loon Preservation Committee for their outstanding help in rescuing a group of loons stranded off Tuftonboro Neck in February.

Tuftonboro hosted a state certified Ice Rescue Technician class. The class room portion was held at 189 Middle Road Tuftonboro Central Station on 3/23/203 and the practical day was on 3/25/2023 at Union Wharf dock 19 Mile Bay. There was 14 students in the class 4 of which are members of Tuftonboro Fire Rescue. We also had 3 members of the department who instructed and assisted with instructing the class all went well.

The new car 1 which was approved at town meeting is in the process of being ordered.

The radio cabinet for radio upgrades at 189 Middle Road has been placed on the cement pad at the new tower sight. This was completed on 3/24/2023 by Ossipee Mtn Electronics. My self and FF Medic Mike Dow. Antennas will be placed by the cell company and the radio equipment at the station will be moved into the outdoor cabinet. This will be an ongoing process until complete.

As the chairman of the Ossipee Valley Mutual Aid Association, the area fire chiefs and members of the mutual aid had a leadership round table on March 20th at the training room at the Tuftonboro Central Station.

We met with Commissioner Robert Quinn we received reports from the Division of Safety: Fire Marshall Sean Toomey, Director of Fire Standards and Training and EMS; Justin Cutting, Homeland Security and Emergency Management Director Mark Doyle, NH Association of Fire Chiefs President Larry Best and Executive Director Brent Lemire.

We were able to discuss important safety related issues across the region such as radio communications for the area and recruitment and retention.

I felt it was great that the state officials had this meeting with us. I believe it shows that they do want to learn what the issues that we are facing and work to solve those problems.

We also covered information on where personal can go to get assistance with mental health issues. This is the first time I have seen this type of meeting in the area since I started in the fire service 36 years ago.

For emergency management I am working with Road Agent Jim Bean to see how much damage the town has due to the severe storm and flooding that occurred on December 22-25 2022. On March 15 2023 President Joe Biden declared a major disaster for Belknap, Carroll Coos and Grafton Counties. The initial damage assessment was \$50,000 but Jim Bean believes it will be higher once the snow has melted and we can get a better look at the areas that were damaged
