CALL TO ORDER

Chairman Marcussen called the Selectmen's meeting to order at 1:10 pm.

MINUTES

Selectman Albee made a motion to approve the 4.5.2021 BOS meeting minutes as corrected. Selectman Pike seconded. Motion carried 3-0. Selectman Albee made a motion to approve the sealed 4.9.2021 nonpublic minutes as presented. Selectman Pike seconded. Motion carried 3-0.

APPOINTMENTS

The Selectmen met with Chief Thompson to discuss the Engine 4 fire truck engine failure; this is our 2005 HME based out of the Mirror Lake Station. The towing bill was \$1856.25, and the repair bill will be \$38,699.03, totaling \$40,950.28. The company requires a \$24,200.00 deposit before they will start the repairs.

The Chief spoke with Moultonborough to see if they had a truck Tuftonboro could rent from them until our tuck is repaired. Moultonborough has agreed to allow Tuftonboro to used one of their trucks at no charge. The Chief confirmed with Primex, Tuftonboro's insurance carried, that the loaner truck would be covered if there were any issues, the insurance would transfer to the loaner truck.

The Selectmen and Chief Thompson discussed budget concerns. The truck has 4-5 years left to be in service. The schedule could be pushed out now or the truck could be kept as a spare truck once its replacement truck is purchased. Selectman Albee made a motion to have the repairs completed for \$40,950.28 and to submit the deposit of \$24,200.00 to have the repairs started. Selectman Pike seconded the motion. Motion carried 3-0.

Selectman Albee made a motion to sign a Gravel Tax Levy 55-3-3 op# 20-455-06E. Selectman Pike seconded. Motion carried 3-0.

Selectman Albee made a motion to sign a Right to Burial for Michael Martell Sr. – F57. Selectman Pike seconded. Motion carried 3-0.

Selectman Albee made a motion to sign the Tents R Us Agreement. Selectman Pike seconded. Motion carried 3-0. This agreement is to rent the chairs and tent for the May 15th Town meeting.

The Selectmen reviewed an email from the Chandler Road and Shirley Way residents asking what work will be done on their roads this year. Jim Bean reported ditching has been done so far this year. The Selectmen will discuss these roads with the Road Agent when they meet with him at his May update. The Selectmen reviewed the Swim Lesson's registration form and requested it be sent to Primex for review. The Selectmen reviewed Jim Bean's written update for April.
