# MEETING MINUTES Thursday, February 10, 2022

<u>Present</u>: Chairman Gordon Hunt. Members: Selectmen's Rep Chip Albee, Gary Chehames, Chris Sawyer, Bob Theve. <u>Not Present</u>: Vice Chairman Barry Ennis, Penny Hug. <u>Staff</u>: Jane Lemire.

#### I. Call to Order

Chairman Hunt called the meeting to order at 6:30 p.m.

#### Budget Committee Suggested Operating Budget

Chairman Hunt proceeded by reading aloud each department's 2021 budget total and the 2022 budget total. (See attached). He gave a brief overview of each department's goals and answered pertinent questions from the group.

Chairman Hunt reported that the BOS decided upon a revaluation of property in 2022 thus resulting in the need of an additional \$40,000.00 being added to the assessor budget for this purpose. Property valuations are typically done every five years; however, due to the substantial increase in property values because of the present-day housing market/economy, the BOS determined a revaluation should take place in 2022.

The 2022 total operating budget total (including the added expense of revaluation of property) is \$4,409,340.00, an approximate 4.85% increase over last year's budget of \$4,195,600.00.

#### Warrant Articles

Chairman Hunt proceeded by reading aloud each of the ten warrant articles as well as answering pertinent questions from the group. (See attached).

#### 2022 Estimated Revenue

Chairman Hunt reviewed and read aloud the 2022 estimated revenue report as well as answering pertinent questions from the group. (See attached).
