I. <u>Consideration of Minutes</u> March 20, 2017

> <u>It was moved by Lloyd Wood and seconded by Nancy Byrd to approve the March 20, 2017 Tuftonboro</u> <u>Conservation Commission minutes as submitted. All members voted in favor. The motion passed.</u>

March 20, 2017 Nonpublic Minutes

It was moved by Nancy Byrd and seconded by Kate Nesbit to approve the March 20, 2017 Tuftonboro Conservation Commission nonpublic minutes as submitted. All members voted in favor. The motion passed.

The Board agreed the March 20, 2017 Nonpublic minutes would remain sealed.

II. Discussion Items

A. Rules of Procedure

The Commission reviewed its Rules of Procedure, revised per the 2/20/17 Conservation Commission minutes, and agreed to the following (further) revisions;

- Include list of revision dates
- Article VI.B.D. Attendance; insert "4 (four)" prior to "consecutive"
- Article VIII.c., 1st sentence; insert a comma following "Annually" and strike "the Conservation" & replace with "each Conservation"

It was moved by Larry Gil and seconded by Kate Nesbit to adopt the Conservation Commission Rules of Procedure as amended. All members voted in favor. The motion passed.

C. Well Water Testing Initiative

The Commission discussed whether to hold the Well Water Testing Initiative this year and agreed to do such. Due to the decrease in the amount of kits being distributed, the Commission agreed to continue the program however, on a two year schedule (following 2017) and publicize such. The Commission also agreed to insert the flyers into the tax bills. The Commission agreed to schedule the dates as follows;

Distribution of kits: Monday – Saturday, July 17-22 Collection of kits: Sunday, July 23

Transportation of kits to Concord: Monday, July 24

Nancy Piper stated she spoke with Lou Barinelli who informed her that the State could support the program if 75 or less kits were received.

Steve Wingate volunteered to submit an article in the Tuftonboro Times.

New Permit By Notification application to replace existing dock and platform at the shoreline; full crib replaced in-kind. Reviewed by Nancy Byrd; no objection.

New Permit By Notification to replace an existing concrete public boat ramp with new concrete; same size, location and construction type. Reviewed by Mark Howard; no objection.

New Standard Dredge and Fill application to install a 28' steel header attached to the existing shoreline stone to support two 6'x40' aluminum seasonal crank up docks with a 6'x16' crosswalk in a U-shaped configuration with wooden stairs as an egress to the upper bank. Reviewed by Mark Howard; no objection.

Approved Standard Dredge & Fill application to perform maintenance dredging for existing slips (19.5 cubic yards of material to be removed) and rework existing wall within the owner's property to accommodate a greater boatslip depth.

TM #2-1-77

Approved Minimum Impact Expedited application to perform maintenance dredging to remove sand which has deposited over the years.

Mueller Family Trust 2 Loon Point

TM #2-1-73

Approved Standard Dredge & Fill application for an after-the-fact minor impact wetland permit; noting that two rocks were moved from the sea plane launch area where they caused a potential hazard for utilization of the ramp. However, the rocks began to shift upwards, resulting in the rocks protruding from the water. The rocks were picked up and moved so that they would not pose a safety threat.
