## A. Guest; Joan Gale

Joan Gale stated she would like to protect her land, Tax Map 15-2-15, 5 Gomorrah Way (19.5 acres).

The Commission and Ms. Gale discussed conservation opportunities and provided Ms. Gale examples of two conservation easement deeds.

It was moved by Lloyd Wood and seconded by Nancy Byrd to appoint Kate Nesbit and Mike Phelps as a subcommittee to discuss conservation opportunities for Tax Map 15-2-15. All members voted in favor. The motion passed.

#### B. Keith Garrett Resignation

Steve Wingate stated Keith Garrett has accepted a position at the Mount Washington Observatory and is relocating therefore, Mr. Garrett has submitted his resignation. He stated the BOS appointed Mr. Garrett to the Commission therefore, the resignation should be accepted by the BOS rather than the Commission.

Staff informed the Commission a memorandum regarding such was submitted to the BOS.

### E. Well Water Testing Initiative

### F. Mirror Lake Protective Association Report

Larry Gil forwarded a memo to the Commission in his absence informing the Commission of the following;

- Participated as Lake Host Manager for Mirror Lake and participated in Weedwatch program
- Attended Invasive Species of NH workshop hosted by Doug Cygan, NH Department of Agriculture (pamphlets are located at the Town Hall) and attending a site walk on 7/22/16 with Tracy Tarr and Mark Howard to discuss invasive species within the ROW and the BMPs available for water crossings
- Chinese Mystery Snail observed in Mirror Lake
- MLPA Board of Directors met and issues regarding the lake's low water were raised
- Expressed concern (both he and MLPA) regarding Wolfeboro's proposal to renew the use of the spray irrigation fields
- Retrieved copy of the latest sampling associated with the landfill permit and will schedule a walk to locate the sampling sites and look for seeps

Steve Wingate stated Mark Howard is currently working on simplifying the format of such.

#### **Great Meadow**

Kate Nesbit stated she has been in contact with one abutter to the Great Meadow and has attempted to contact another to discuss conservation opportunities.

Steve Wingate stated he would present the proposal to purchase property from Sarah Crane Fabian, abutter to the Great Meadow property, to the BOS on 8/1/16. He noted the Purchase & Sales Agreement is contingent upon a clear title; noting the closing is scheduled for 9/15/16. He stated the BOS need to approve the acceptance of the funds being donated by the Land Bank of Wolfeboro Tuftonboro prior to the Conservation Commission accepting the funds and need to approve the expenditure of funds for the acquisition of the property. He stated the conservation commission must hold a public hearing to allow citizens to comment on the proposed expenditure and vote to expend the conservation funds.

The Commission scheduled a public hearing for 8/15/16.
